**Remember...** Be it known that under MA General Law, Chapter 60B, Section 4, two penalties may be assessed for failure to pay Boating Excise Tax when due. This includes a \$20 or 20% penalty and the Harbormaster shall refuse to allow the vessel to "moor, dock, or otherwise be situated within the waterways" of the Town.
